PRESIDENT'S WELCOME



"In 1884 a meeting at Young and Jacksons in Melbourne established the Anglo-Australian Football Club, playing under British Football Association rules and this has provided Football Federation Victoria with a 125th anniversary to celebrate in 2009." The Story of Football in Victoria by Roy Hay and Ian Syson.

In 2009, we celebrated a milestone in achieving 125 years of football in Victoria.

To kick off the year-long celebrations for this amazing achievement, Football Federation Victoria (FFV) held an official function at Young and Jacksons where it all began for Victorian football all those years ago. It was at this event, which also saw the launch of the 2009 Victorian Premier League season, that FFV released the 125 year corporate logo.

The 2009 Gold Medal Night focused on a 125 year theme, with guests treated to a 125 year highlights DVD made up of images and video footage from our historical

archives. Two new awards were also presented at the Gold Medal Night, the Best News Article, won by Chris Vernuccio from the Leader Newspapers, and the Les Shorrock Best Football Image Award, which was won by Sally Richards from the Shepparton News.

Two of our great clubs also celebrated significant milestones in 2009; both South Melbourne FC and the Preston Lions celebrated their 50th anniversaries. A special video celebration was put together and shown to all who attended the 2009 Gold Medal Night.

FFV and Northern NSW came together in Newcastle, NSW, to recognize both state's historical milestones, as Northern NSW also celebrated their 125 year anniversary in 2009. A men's and women's representative side travelled to Northern NSW to take part in the friendly in September.

To preserve the history of our game, a Historical Committee was founded. From this Committee, a Hall of Fame Criteria was developed, with work already started on the FFV website to showcase the history of football in Victoria.

Rounding off the 125 year celebrations in December, Roy Hay and Ian Syson's historical book, The Story of Football in Victoria, was officially launched by Minister for Sport, Recreation and Youth Affairs, Minister James Merlino, and presented at the Life Members annual lunch at Young and Jacksons.

From a Board perspective, we have been extremely proud of a number of initiatives that were introduced and implemented in 2009.

Firstly, the inaugural Summer League competition saw almost 2,000 boys and girls from the 12 Zones in Victoria take part in a 16 round 'home and away' season and a finals weekend. This competition is designed as a pathway program for our talented players, and was introduced to ensure that we keep up with the rest of the world, and have footballers, coaches, and referees involved in the game all year round, and the Summer League competition allows for this. The very best players

in the Summer League can then be selected to play for Victoria and hopefully don the green and gold in the years to come. We have already seen success with the program through Matthew Leckie who, in 2009, was picked up by Adelaide United in the Hyundai A-League.

In February 2009, following the inaugural season, a review was undertaken to understand where the newly formed League needed improvement. From this the Summer League was re-branded to the Victorian Champions League to better reflect the representative nature of the competition, and each of the Zones were provided with a new nickname, identifiable colours, new logos and a playing strip. The result heading into season two was a new-look League with an aspirational feel.

In 2009 a new club development program, Football ACE, was introduced, and in July, Minister Merlino presented Knox City with the first Football ACE Group Stage, Level 1 Certificate of Accreditation. Congratulations to Knox City on this outstanding achievement.

In July our brand new website was launched. The new site significantly benefits our clubs and other key stakeholders by providing an easy-to-use site, with greater access and more up-to-date, prominent and diverse information. It presents Victorian football in a way that is accessible to everyone – from Mums and Dads, to senior players, coaches, referees and all the kids who line up each week with their friends to have a kick.

Something we can all be immensely proud of is the milestone of player registrations in Victoria eclipsing 50,000 in 2009 – a staggering 25% increase from 2007. I'm thrilled with the knowledge that all the hard work being done by FFV, the Clubs, and volunteers is helping to grow our sport in Victoria.

To help raise much-needed funds for the Black Saturday bushfires, a combined Victorian Premier League Men's team went toe to toe against Melbourne Victory FC in a three-game Bushfire Appeal series. The games were held at Olympic Park Stadium, Mansion Stadium and finally concluded in Shepparton. Thank you to Melbourne Victory FC for taking part and to all who attended and donated to

the cause that changed Victoria forever.

Looking to work more closely with Clubs throughout all of Victoria, FFV worked with the Geelong Region Football Association (GRFA), where it was decided that GRFA would integrate itself fully with FFV. This historic announcement fits in with our Strategic Plan in that it will strengthen the delivery of our sport in regional areas and enable the clubs to work more collectively to grow the sport in the region and it is also pleasing that the Bendigo and Mildura regions have also subsequently agreed to fully integrate. We will continue to work with other regional associations to help deliver football in a more professional and streamlined manner.

In 2009, we continued to build on the strong relationships we have developed with the Victorian State Government, VicHealth and our national body, Football Federation Australia (FFA). I would like to thank them for their continued support and look forward to an exciting 2010.

Our 125th year has certainly been one to remember, and I would like to thank my fellow Directors, who have continued to work tirelessly with tremendous dedication in 2009, further ensuring the continued development and growth of our great game in Victoria.

I would also like to thank Mark Rendell and his executive team comprising Belinda Wilson, Kerry Harris, Matt Usher, Lydia Dowse (now Tim Frampton) and of course all their support staff for their continued commitment and support during 2009; I look forward to working with them all on the exciting initiatives we will undertake in 2010.

Finally, thanks to all who played, coached, refereed and volunteered their valuable time to Victorian football, for without your continued support we would not be able to achieve the continued positive growth of our great game in Victoria.

STRATEGIC PILLAR 1 FOOTBALL DEVELOPMENT

Facilities Development

Synthetic pitch development is continuing with new community pitches coming on stream at Bulleen, Mill Park, Bendigo, Somerville, Fawkner, Hoppers Crossing, Melton and Caroline Springs.

In the 2009/2010 Victorian State Budget the Government made a commitment of \$5.7 million over three years to the Strengthening the World Game Program to respond to Victoria's rapid population growth, significant growth in football participation and the consequent increased demand on existing community football facilities.

The development of **Kingston Heath** as a full regional facility with one natural grass pitch and two synthetic pitches will provide the 'A' class regional venue for all Bayside and Kingston clubs requiring higher order facilities, provide additional summer and winter training and generally serve as the regional development venue from mid 2010.

The **Knox Football Centre** is a critical development for FFV, involving a \$1 million investment in two synthetic pitches and pavilion in partnership with Knox City Council. The centre will be operated by FFV and provide match. training, player development and recreational football facilities.



Game Development



The aim of FFV's Game Development Department is to develop and support football in Victoria across a number of areas, including club development, small-sided football, schools programs, women's football, coaches and the Victorian community.

In 2009, the **Schools Program** was further enhanced with the inclusion of the FFV School Holiday Program with a total of 140 school-aged children participating in small-sided football activities.

The delivery of Melbourne Victory Football Club School 5-a-side Gala Days increased in 2009 to thirty-six. Approximately 240 schools, and close to 6,000 boys and girls participated in the program during the course of the year - doubling the figure achieved in 2008. The expansion to more regional areas was a major factor contributing to this achievement.

The FFV Sports Development Program was a new initiative developed in partnership with Sport Education Development Australia and Victoria University. The program saw 95 students aged 16 – 19 years complete a Certificate 3 and 4 in Sport and Recreation. The students took an active role in all FFV operations and delivered FFV Programs to over 30,000 primary school students.

A total of 28 schools and 49 teams took part in the annual All Schools Championships.

In 2009, 938 **new coaches** become accredited, with an additional 1114 parents completing the Grassroots Certificate. Monthly coach education seminars and an annual state conference were also delivered to accredited coaches in 2009 to ensure professional development opportunities were continually offered to the coaching fraternity. Approximately 500 coaches attended the fourteen seminars and conferences.

For referees 21 Level 4 courses were run in 2009 with 196 attendees. Approximately 140 new members refereed in 2009.

Across 194 registered centres state-wide, 13,000 boys and girls aged 5 – 10 years participated in the nationally consistent Optus Small-Sided Football playing formats in 2009. As per our strategic objective, Optus Small-Sided Football will be fully implemented in Victoria from 2010.

FFV launched a new club

development program at the start of the season, Football A.C.E (Achieving Club Excellence), with support from the Department of Sport and Recreation Victoria and Football Federation Australia. At this time, 25 Clubs have reached Group Stage Accreditation.

The Club Compliance By-law was introduced in 2009 to ensure all Clubs wishing to compete in FFV competitions comply with the definition of a 'Club' as provided under FFV's Constitution and FFV's Rules and Regulations. It is important for the growth of Clubs and football in Victoria that all participants, coaches and other members have a say in how their Club is run, as this

provides diversity, equality and ownership. FFV's role is to assist Clubs in having an effective Club structure and to help wherever possible to facilitate this process.

Community Development

encompasses four main areas, social football, wheelchair, indigenous and inclusive programs. In 2009, Wheelchair Football experienced its greatest season in many years with thirty-six players participating in the South East competition. Plans to expand the program are on track with nine comeand-try days in the North West resulting in an average of 18 participants at each session.

Indigenous Victorian footballers had the opportunity to participate in the first ever National Indigenous Football Festival held in Townsville in 2009. Players were identified throughout regional Victoria to be included in the Marngrook Meenteel (Victorian All Stars). By the end of the year an Indigenous Advisory Committee was established consisting of Indigenous leaders to assist in providing easier access to football

for all Indigenous Victorian's.

Trials took place for the Beach Football Australian team in February 2009. FFV is hoping to provide Beach Football as a regular competition in the summer months from 2010. FFV continued its support of the Access for All Abilities Football programs from club level (currently 13 AAA programs), community level (come and try days) and state level (Paralympic Youth Games).

FFV is continuing to work with partner organisations to deliver participation and education opportunities for people from a Culturally and Linguistically Diverse background including the All Nations Women's Cup, Coaching and Referee courses.

FOOTBALL DEVELOPMENT

Talented Pathways

After the successful induction of the 2008/09 Summer League Season, the Talented Player Pathway became more clearly defined and allowed State Squad Coaches to select quality players from the 12 Summer League Zones for the 2009 National Junior and Youth Championships.

State Coaches were selected from those that took part in the 2008/09 Summer League, and 2009 saw the introduction of a Talented Officials Program (TOP) which identified up and coming Referees who could officiate Men's State League One and Premier League competitions in future seasons.

National Junior and Youth Championships

Following an invitation to the Asian Football Confederation (AFC) Festival of Football for both Under 13 Boys and Under 14 Girls, Football Federation Australia restructured its programs to introduce the first National Junior Championships. Held in Canberra during April, the tournament acted as identification for the inaugural National Junior Squads.

Victorian players benefited from a summer of football and seven boys and four girls were identified to attend their respective National Camps for future selection. At the



conclusion of the camps, eight Victorian players (four boys, four girls) donned the green and gold competing for Australia in Vietnam and Malaysia during May/June 2009.

At the National Youth Championships in Coffs Harbour, Victorian squads had mixed results, but pleasingly, the Under 14 Boys Metro defeated NSW Metro 2-0 in the final to take home the Championship. The Under 15 Boys Metro reached the finals, winning a third versus fourth playoff against South Australia.

Coaching

Summer League 2008/09 provided a clearer pathway for Coaches wishing to further their qualifications and experience. Summer League coaches were required to have at least their Youth License, while Head Coaches required their B Licence. In 2009, many of the State coaches were selected from the pool of Summer League coaches from 2008/9, and this reflects on the success of Summer League in providing a stepping stone for all participants in Victorian Football. Bobby McGuinness, a Summer League Coach in 2008/9, was selected as Head Coach of the Under 14 Boys Metro side who he took to victory at National Junior Championships.

Referees

The 2008/09 Summer League and Talented Officials
Program (TOP) have both highlighted potential future top
referees with a number of previous TOP Graduates moving
along the Match Official pathway, into Men's VPL and
State League 1 for season 2010. One of those, Alejandro
Azcurra, has been selected to participate in the AFC Elite
Referee Program for the next two years. There should be
at least another five dedicated Graduates moving forward

at the end of 2010 course. Another group of referees who were identified with potential have been added to the Victorian Premier League U21 and Womens Premier League Panels for the upcoming season.

Competitions

In 2009 FFV competitions saw an increase in junior team entries (up 33% since 2006 for the Metro Competition), the introduction of finals for Women State One, Two and Three, and the Sunday Men 'Thirds' Competition was restructured into a promotion and relegation system.

In 2009 there was an overall increase in junior team entries, particularly the junior boys which saw an increase of 4.3% compared to 2008. Planning for the 2010 Junior Competition was a major project for the Competitions Department in 2009, which will see the Junior Competition head into a new and exciting direction with the new Junior Zone pathway for 2010. This will enable the sport to compete more effectively with other sports that vie for the participation of our junior athletes.

Tribunal and Discipline

2009 saw the Tribunal and Disciplinary Department achieves significant outcomes. In the broad areas of Tribunal and Appeals Board cases, Red/Yellow Cards, and Fines, the overall number and general severity of cases reduced significantly. Backed by the zero tolerance objectives of the GDT By-Law which comprised of increased penalties (fines) and tracking repeat offenders (penalised with point deductions), coupled with the integrity of the Tribunal, which was again held off site at the Dallas Brooks Centre in East Melbourne, the end results were most satisfying for FFV and the wider football community. 151 cases heard by FFV's Tribunal in 2009, this compared to 161 cases heard in 2008; a reduction of 10 cases occurred. This is a significant reduction taking into consideration the amount of registered players in 2009 was higher than that of 2008, and the 2009 figure includes Match Official Commissioner Hearings that were not heard in 2008.

FOOTBALL DEVELOPMENT

Summer League

The inaugural Summer League Competition, a new initiative within the FFV's participation and representative pathway, kicked off in October 2008. The season saw almost 2,000 participants across eight age divisions (four male and four female) and from 12 Zones, take part in the 16 round 'home and away' season, followed by a finals weekend for those who finished in the top four.

Planning for the 2009/10 Summer League Season took place at the completion of the inaugural season in February 2009. Highlights of the changes resulting from the review include a reduction in the competition length to reduce the post-Christmas clash with winter pre-season trials and training and deliver a fixture within which teams play each other only once, the introduction of a metropolitan gala round (double header) and a new-look 'Championship Series' to replace the finals series in junior age groups which allows all teams to compete throughout.

Registrations

For the first time in Football Federation Victoria's history, player registrations eclipsed 50,000 (51,591, outdoor football). This was over a 5% growth from 2008 and a staggering 25.1% increase from 2007. Male players make up 82.6% of all player registrations, with female players making up 17.4% of all player registrations, an increase from 2008. This increase is reflected in both junior and senior female player registration figures. Junior players (18 and under) make up 78.5% of all player registrations. Regional Victoria is the biggest growth area, which has grown over 16% from 2008 to now make up over 30% of all player registrations. Other notable areas are International Player Clearances which increased by 31% from 2008 and Players changing Clubs during the Season (Supplementary Registrations) increased by over 10%.




Futsal

State School and State Club Futsal Championships were moved to regional Victoria in 2009, the events were still a success considering it was the first time they were held outside of metropolitan Melbourne.

The Melbourne Futsal League encompassed five divisions in 2009, Open Men (new), Under 16 Boys (new), Under 14 Boys (new), Under 12 Boys and Under 11 Boys. The Australian Masters Games took place in February 2009 in Geelong with 150 participants and 13 teams. In June the State School Futsal Championships were held in Bendigo with 72 teams and 500 participants taking part. This was followed by the State Club Futsal Championships in July in Warrnambool, where 300 participants made up the 40 teams that entered.

In conjunction with Ashburton United SC, the Ashburton Futsal League continues to offer social players the opportunity to get involved and enjoy the game of Futsal. With eighteen teams over two divisions, the league continues to develop since its conception in 1994.

STRATEGIC PILLAR 2 BUSINESS DEVELOPMENT

Events

2009 saw the implementation of a significant regional events program by FFV in conjunction with its partner in this area – Complete Sports Marketing. This program has the dual benefits of taking more significant football events to regional areas in Victoria as well as delivering a significant revenue stream for FFV. Key events delivered as part of this program in 2009 included: Summer League Regional Gala Rounds in Geelong and Bendigo; Victorian Premier League Anzac Day football with Green Gully versus Heidelberg at Tom Flood Arena in Bendigo; Bendigo Boys FC – an annual football tournament for boys from Under 11 through to Under 16; State Futsal Championships in Warrnambool and the State Futsal Schools Championships in Bendigo; and the Melbourne Victory versus Victorian Men's State Charity Bushfire Series game two in Shepparton.

Sponsorship

A key focus in 2009 was the improvement of existing FFV commercial assets (including the FFV website), the creation of new ones (including the Victorian Champions League) and a focus on leveraging FFV commercial assets more effectively for the FFV and its commercial partners. New sponsorships in 2009 include: Events Worldwide, Clear Solar, Shanghai Qingpu District Tourism Administrative Bureau (supporting partner of the Melbourne Victory Women's team), Schweppes, The Athlete's Foot, TigerTurf and Loyalty.com.au.



Licensing Program

Apparel and Ball Licensing continues to be a strong form of revenue for FFV and 2009 saw out the final year of our 2007-2009 apparel and ball licence agreements. Our six Apparel Licensees adidas – LWR Teamwear, Covo, Diadora, Errea, Hummel, Kelme, Mitre and Nike and our four ball licensees – Mitre, Nike, Patrick and Spartan had a successful 2009. Diadora participated in our Junior Ball Program, providing a special 125th year ball to all registered Junior Players.



Media

The implementation of a new FFV website in July 2009 was instrumental in showcasing Victorian football in a fresh, modern way. The new website significantly benefits clubs and other key stakeholders by providing an easy-to-use site, with better access and more up-to-date, prominent and diverse information.

In 2009, scores and finals results were published in mainstream newspapers, The Age and Herald Sun, while community newspapers continued to provide media coverage to all levels of football in Victoria. Greater media coverage was given to football in regional Victoria through the introduction of the state-wide Summer League competition.

Summer League

The inaugural zone-based Summer League Competition, saw almost 2,000 participants across eight age divisions (four male and four female), and from our 12 regional Zones take part in the 16 round 'home and away' season, followed by a finals weekend for those who finished in the top four.

A partnership with Covo saw every team issued with both a home and away playing uniform, gala weekends in regional Victoria hosted in partnership with local councils and all Zones represented in at least one age division during the finals, with seven different Zones victorious on Grand Final Day.

In February 2009, following the inaugural season, an extensive review was undertaken to understand where the newly formed League required improvement. An online survey was made available to all players and parents to provide their feedback, as well as individual meetings held with each Zone.

The most significant improvement was the branding project undertaken by FFV in consultation with a number of stakeholders. To better reflect the representative nature of the competition, the League was re-named the *Victorian Champions League* and each of the Zones provided with a nickname, identifiable colours, new logos and a playing strip. The result heading into season two was a new-look League with an aspirational feel to it, particularly given that a number of the playing strips mirror those of some of the world's most famous football teams.

Venue Hire

FFV took more than 15,000 pitch bookings at the Events Worldwide State Football Centre in 2009. The main user groups across these bookings were FFV Affiliated clubs, Community Groups and Schools as well as FFV's own Talented Player Pathway programs and Game Development initiatives.

STRATEGIC PILLAR 3 CUSTOMER SERVICE



Government Relations

FFV's Government Relationship Manager personally visited clubs and Councils in every Zone in Victoria in 2009 and has held meetings with 58% of Councils with football clubs and substantial telephone contact with a further 10%. Face-to-face meetings have been held with 80% of Councils which have teams directly managed in FFV competitions.

Registrations

During 2009, FFV undertook pilot testing of FFA's national on-line system; MyFootballClub, with a number of Clubs volunteering to be part of this process. This culminated in a Focus Group session with Football Federation Australia, outlining FFV and the Pilot Clubs feedback that would be used to further develop and enhance the system for delivery to FFV and other member federations in 2010.

Referees

The Referees Department allocated 3000 referees and linesmen for Clubs, Schools, Community and Social groups in 2009, with many of these being for large tournaments including Australian Corporate Games, Manchester United Cup and Paralympics. The improved FFV website allowed for the inclusion of Referee Rankings, Directives and educational subjects which have provided a transparent environment for Match Officials and Clubs.



Competitions

2009 saw a positive reduction in the number of fixture changes (15%) due to improved delivery of service to Clubs prior to the season with fixture requests thereby minimising the impact on all stakeholders of these changes.

Tribunal and Discipline

The Tribunal and Disciplinary Department was proactive in promoting the zero tolerance objectives through the "Don't Abuse, You May Lose" campaign which saw the design and distribution of thousands of posters and educated Clubs Associates on the consequences of breaching the GDT By-Law and Rules Of Competition.

Customer Satisfaction Survey

The FFV Strategic Plan has the goal of achieving an 85% satisfaction rate with customer service by 2011, measured annually on-line by independent research. In late 2009 FFV engaged Sport Business Partners (SBP) to conduct an independent survey into clubs' customer satisfaction levels. Over 4,600 FFV stakeholders were invited to take part in the Customer Satisfaction Survey with 338 completed surveys being collected by SBP.

The current level of satisfaction with FFV's customer service is 66% and FFV has now established a starting point to work from. Further analysis shows one in five (22%) are extremely or very satisfied, with an additional 44% being fairly satisfied. It is important to note that those respondents identified as Key Administrators had an overall satisfaction rating of 68% and generally rated higher in most areas of the survey than other respondent groups.

The **Key Drivers of satisfaction** include the professionalism of staff, the quick response to queries, the improvements in standards, the improving communication and concise information. That said there are many that offer suggestions to help improve satisfaction levels such as responding quickly to queries, lack of support at club and regional level, lifting communication levels and standards, among others.



Relocation

FFV relocated to Level 3, 436 St Kilda Road Melbourne in mid-November 2009. The new offices have excellent features including more meeting rooms for clubs and stakeholders; a Training Room which can seat up to 50 people for large seminars; four hot desks which stakeholders can use for registrations and other functions, and a cashier's desk for more efficient payments. FFV's Head Offices are now centrally located which affords clubs from all over Melbourne greater access to undertake club administrative tasks.

Game Development

The Victorian Government and FFA continued their support of the Volunteer Recognition Program in 2009. Over 2000 Club Volunteers registered for the VRP and were recognised for their services to football and to their clubs.

STRATEGIC PILLAR 4 LEADERSHIP

FFV Board of Directors

The FFV Board of Directors entered year two of its Strategic Plan and continued to implement policies and processes in line with the strategic goals of the organisation. With staff now working under a new structure, streamlining systems and processes continued to be a high agenda item for the Board.

June was a busy month for Board Governance with some Directors embarking on self development through the Leadership Victoria - Board Orientation Series. Five out of the eight Directors attended this workshop series to further enhance their skill set through good governance practices. Prior to this, a Board Engagement Policy was released to members outlining the guidelines under which the Board will operate for enhanced interaction between the Board and stakeholder groups.

In August 2009 FFV was selected from a number of applications to take part in the VicSport "Good Governance Project". This project is set to complete in August 2010 and was designed by VicSport and FFV to help identify and engage the Board in developing better governance and leadership processes and procedures.

The FFV Board identified two skill gaps which existed on the Board and after comprehensive research appointed two new Directors, Annette Hughes and Bridget Marcou to assist in the specific areas of Legal and PR / Communications respectively. Both Annette and Bridget bring extensive experience and offer valuable insight in to these two areas.



Elected Representative Survey

With the commencement of newly elected Zone Representatives and Standing Committee members and as part of the Board Engagement Policy, the FFV Board undertook a survey with newly elected representatives. The survey produced positive results in the areas of the 2008-2011 Strategic Plan, Men's and Women's Football, Club Development, Referee and Coach Development showing an 84% rating as either "Satisfied" or "Fairly Satisfied" with the direction the FFV is taking in implementing strategic initiatives.

Survey results also indicated that members view Referee and Coaching Development as a "Very Important" items going forward with ratings of over 70% for "Very Important".

FFV Staff

Operationally FFV continued to work on developing strong leadership amongst the senior management group and continued to build a strong foundation to set the organisation up going forward.

The Senior Management group joined the Board of Directors in May 2009 to discuss the strategic priorities for the organisation and worked together on ensuring a cohesive and tight knit relationship continues to grow between the two groups.

With regular Management Meetings and Staff Meetings now set in place, this has enabled internal communication lines to open further and ensure that staff adopt a more fluid relationship between departments and teams.

With the departure of Lydia Dowse as General Manager – Football in October, it was crucial a suitable replacement was identified to join FFV and continue to lead the Football team in a positive light. Tim Frampton joined the organisation in November bringing with him an extensive sports legal background, one which has proved to be a valuable asset to the organisation thus far.

Government Relations

Since the appointment of a Manager in early 2009, the Government Relationship Department has made successful progress in achieving FFV's strategic objectives in attracting additional Government investment in the sport, improving the quality and quantity of facilities and creating commercial opportunities.

In particular the key successful outcome for the sport has been the very substantial increase in the number of synthetic pitches. The Victorian Government has been a leader in promoting the use of synthetic pitches for football, largely to deal with high demand in a period of lack of water. Victoria now has more synthetic pitches than the rest of Australia combined.

Football Planning

FFV is strongly involved in football strategy development across the State, including participation in the North West (Metro) Regional Football Strategy, following up the the Bayside/Kingston Soccer Strategy and the Eastern Region Soccer Strategy, the Surf/Coast Geelong Regional Facilities Review, the Geelong Region Football Strategy (funded by State Government and four Councils and the current feasibility study on the development of synthetic pitches for City of Banyule.

FFV has actively supported FFA's National Facilities Audit, data from which will be used in the further planning of facilities in Victoria. FFV has also provided extensive support to FFA and SRV in the process of identifying facilities for the World Cup bid.

Communication with Government

FFV has been engaging with government at all levels, including regular meetings with Councils and State Government, establishment of a specific Government section on the FFV website, Local Government workshops on club accreditation and facilities requirements, a survey on season planning and ground availability and liaison on the Strengthening the World Game funding program.





2009 FINANCE REPORT For the year ended 31 October 2009

This report shows how Football Federation Victoria (FFV) performed financially during the 2008/09 financial year. It also provides the overall financial position of FFV as at 31 October 2009.

FFV has generated a surplus of \$270,710 for the 2008/09 financial year. There are several contributing factors to this surplus such as improved budgeting management including regular budget reforecasting, increased revenue and close monitoring of expenses, details of which are provided below.

Grant Thornton undertook the external audit of FFV's financial statements and their unqualified audit opinion is attached to this Finance Report.

Income

The growth of registration, affiliation and team entry income shows the continued growth of football in Victoria. This presents FFV with a welcome challenge in ensuring that there is a comparable growth in facilities to service this demand. FFV's long term strategy is to invest in facilities and also seek investment from like minded partners and government.

The likely source of FFV's facilities investment strategy funding will be our commercial operations. In 2009 solid foundations were laid to develop new operations and improve on existing operations. As these operations mature, increased reliance can be placed on this revenue stream.


FFV's continued work in the areas of sponsorship and grants has also delivered growth in our revenue streams from these activities. The majority of the growth is in grants, which demonstrates the confidence funding agencies have in FFV's ability to deliver grant programs. 2009 was a difficult financial year globally which had the potential to affect sponsorship, however our revenue in this area increased by 68%, another positive sign that there is confidence in FFV's operations.

To remain competitive within the sporting and leisure industry, FFV needs to look at expanding the ways that people play the game and ensure that we are the main provider of all those forms of the game. This presents significant hurdles for an organisation that has low cash reserves to invest in capital, hence the need to increase surpluses in the years to come to build up these reserves.




Expenses

2009 Expenses




