1.2.3 Player Eligibility	<p>Requirements for clubs to submit a player dispensation must provide all relevant documentation which include.</p> <ul style="list-style-type: none"> <li>a) Club supporting the application.</li> <li>b) Signed letter from the players Technical c. Director.</li> <li>c) Signed consent from players parent/guardian.</li> <li>d) supported by a document listing general medical details of the player by a medical professional</li> <li>e) The application must be supported by a maturity offset report for the player provided by a sport science professional.</li> </ul>	
1.2.7 Player Eligibility	<p>In addition, for the Preliminary Rounds, players must be registered to their Club in accordance with any <a href="#">FV Registration Regulations</a> and Rules of Competition applicable to that Club's senior men's team which and in accordance with team tied regulation of the <i>FFA Cup Competition Regulations</i>;</p> <ul style="list-style-type: none"> <li>a. For a National Premier Leagues Club, must comply with the Player Points System.</li> <li>b. For NPL 2 &amp; NPL 3 Clubs, must comply with Senior Club Rosters and Club Visa Player restrictions.</li> <li>c. For Men's State league 1 Clubs, must comply with Visa Player restrictions.</li> <li>d. In the instance an NPL 2 or NPL 3 Club qualifies for the Round of 32 FFA may enforce the club to adhere to the NPL PPS Requirements.</li> </ul>	<p>Regulation clarifies that Clubs may only field players as per the FV Registration regulations and Rules of Competitions applicable to the Club's Senior Team.</p>
1.2.9 Player Eligibility	<p>If in the situation extra time is required to determine a result, clubs are permitted to make a fourth (4<sup>th</sup>) in extra time.</p>	<p>During regular time, clubs can make up to three (3) substitutions. A fourth (4<sup>th</sup>) substitute is only permitted if the game goes into extra time</p>

3.2 Official Match Fees	Match official Fees have been amended to reflect the revised seeding of NPL & MSL for the 2020 Preliminary Rounds	
3.4.3 Abandoned Competition Fixture	If 60 minutes or more of Normal Time of a Competition Fixture has been played, then the score at the time of abandonment may stand. 'Played' in the context of this Rule will be determined by FV with reference to the Match Official.	Rule has been amended to reflect the FFA Cup regulations which replaces FV's process on determining a result if in the situation a fixture has been abandoned.
