

## **2025 Regulatory Changes NPLM/VPLM**

- Football Australia has confirmed the 2025 NPL Men's season will be the final iteration of the Player Points System (PPS) and will be replaced in 2026 with a Player Roster Principles (PRP) guideline document. For 2025 and then into 2026, Senior Rosters are now able to house 2 Visa (Non-Australian eligible) and 1 xOFC/AFC players. The OFC/AFC player is worth the usual 10 points. The PPS remains at 200.
- Key points for 2026 PRP;
  - ➤ NPL Men/VPL1 Men/VPL2 Men will not be able to field a Goalkeeper that is not an Australian Citizen or Permanent Resident
  - ➤ Each Senior team must field at least 5 U23 players and 3 U20 (can be included as part of the 5 U23) players in their match day squad of 17
  - ➤ The Senior playing Roster (between 20-23 players) must include at least 3 'Homegrown' players. This is a player who has played at least 3 continuous years in an underage or U20/23 team in the same club.
- To assist clubs in the transition to the PRP in 2026, Football Victoria will be introducing U19s in the NPL Men, VPL1 Men and VPL 2 Men competitions as part of their Senior playing licences. This will see a further 840+ players remain in the NPL/VPL environment to prepare for Senior Men's Football.



## **2025 Competition Changes NPLM/VPLM**

- Football Victoria has also determined the introduction of key Finals/Playoff fixtures in the Senior Men's competitions will enhance the competition offering for the 2025 season and beyond.
- From 2025, the bottom 3 teams in each of the following competitions; NPL Men, VPL1 Men and VPL2 Men will be relegated to the league below. The teams/clubs placed 3<sup>rd</sup>-6<sup>th</sup> in each of the VPL1 and VPL2 Men will compete in a traditional playoff format (3v6 and 4v5, Winner v Winner) to determine the successful promoted club. For State League Men's North West and South East, the 2 teams finishing in 2<sup>nd</sup> position will play-off for the 3<sup>rd</sup> promotion position.
- Additionally, to support Youth Development in competitive formats, Football Victoria is delighted to introduce a mandatory U20 'Summer Premier League' to be played from October-January of 2025-26 to support the graduation of U17/19 players into U23 and First Team environments in the Men's and U20 players to support with the graduation of U20 players into NPL Women's. This will consist of each of the NPL Men's/Women's clubs for the following season (i.e. 2026) as well as A-League and FV select sides.
